EXECUTIVE SESSION ANNOUNCEMENT

Please be advised that the Chartiers Township Board of Supervisors met in executive session immediately prior to this meeting from <u>5:30</u> to <u>5:55 pm</u> to discuss personnel, contract negotiation and litigation matters.

Noble-Township Manager; James Liekar-Solicitor; Ed Jeffries, Public Works Director; Ashley Neptune-Township Engineer; Parks and Recreation Director, Angela O'Conner; Jamie Rozzo, Recording Secretary; ABSENT: Steven Horvath, Chief of Police; Jennifer Slagle-Director of Engineering and Planning

VISITORS TIME

1. Michael McCaig: Potential 2024 Bond Issue Mr. McCaig discussed 3 options on borrowing for Capital Improvements with the board. The board will discuss how they would like to proceed and get back to Mr. McCaig.

Mrs. Moore 129 Piatt Estates spoke on behalf of Piatt Estates HOA. They have concerns with the detention ponds and feel they need to be addressed before the HOA takes them over. They presented the board with information regarding these items and have asked for their help to make sure these items are completed and inspected prior to the HOA taking over ownership.

The Township is holding financial security from the developer. The developer is responsible for completion of these items. The Conservation District is holding permitting for these items and will require final inspections and approval before the HOA owns the detention ponds.

The Township will monitor the progress of these items and will not release financial security until the Conservation District approves and signs off on these items.

Mrs. Altman 467 Spruce Lane asked the board if there had been any updates on their development. She also asked public works if they could fix a few signs in the development.

Mr. Liekar has been in contact with the developer. The developer has a timeframe to complete the outstanding items. If these items are not completed within the timeframe, the township will act.

Mr. Jeffries will have Public Works fix the signage in this development.

SUPERVISOR REPORTS:

Mr. Shober, Mr. Shober and Frank looked at several properties within the twp. that will be sold by the county. The board did not find any of these properties to be valuable to the twp.

OLD BUSINESS:

 A motion was made by Mr. Wise and seconded by Mr. Shober to authorize the Township Engineer to prepare a scope of services, engineering and bid specifications for 4 pickleball courts in Arnold Park. All Supervisors voted yes. The motion carried 3-0.

The board is concerned with the location of the pickleball courts. They will schedule a core boring to determine if the courts are able to be constructed in this location or if they need to be moved to another location.

2. A motion was made by Mr. Wise and seconded by Mr. Shober to authorize a Washington County Blight Mitigation Grant Application for 201 Arden Road. All Supervisors voted yes. The motion carried 3-0.

NEW BUSINESS:

- 1. A motion was made by Mr. Wise and seconded by Mr. Shober to establish the speed limit on Country Club Road (SR 4049) at 35 MPH in accordance with the Pennsylvania Department of Transportation study and permit dated August 7, 2024. All Supervisors voted yes. The motion carried 3-0.
- A motion was made by Mr. Wise and seconded by Mr. Shober to ratify the Right of Entry Agreement with Aaron Cunko for 77 Welsh Road for the cleaning, repair/replacement of the Welsh Road Culvert. All Supervisor's voted yes. The motion carried 3-0.
- 3. A motion was made by Mr. Wise and seconded by Mr. Shober to ratify the Right of Entry Agreement with Thomas and Nancy Mitchell for 70 Welsh Road for the

cleaning, repair/replacement of the Welsh Road Culvert. All Supervisors voted yes. The motion carried 3-0.

- 4. A motion was made by Mr. Wise and seconded by Mr. Shober to ratify the Right of Entry Agreement with American Legion Post 902 for 124 W Pike Street for the cleaning the storm sewer. All Supervisors voted yes. The motion carried 3-0.
- 5. A motion was made by Mr. Wise and seconded by Mr. Shober to approve the Sewage Facilities Planning Module Exemption Mailer 0.75 EDUs for the Washington County Fairgrounds as authorized by the Washington East Washington Sewer Authority in their letter dated June 27, 2024, in accordance with PA Act 537. All Supervisors voted yes. The motion carried 3-0.
- A motion was made by Mr. Wise and seconded by Mr. Shober to accept the resignation of Helaina Teahan from the Parks and Recreation Board effective the first Monday in January 2025. All Supervisor's voted yes. The motion carried 3-0.
- 7. A motion was made by Mr. Wise and seconded by Mr. Shober to authorize payment of invoices indicated on the enclosed listing. Invoices to be paid are posted on the bulletin board for review.

- 12. Repository Sale Properties-The board determined they are not interested in purchasing properties at this repository sale.
- 13. Chartiers Volunteer Fire Dept Boot Drive-The fire dept would like to conduct their annual boot drive. They have asked the board to sign their PennDOT application for submittal as it is required by PennDOT.
